# 1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2020 Release Wave 2.

This April release replaces Food for Microsoft Dynamics 365 Business Central 2020 Spring Update and is based on Update 17.3 for Microsoft Dynamics 365 Business Central 2020 Release Wave 2 (Application Build 17.3.202104).

## 2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

The extensions in the TI- ... folders are mandatory and part of the base installation for To-Increase applications. They are also “Excluded” from the Extension Management page to limit the number of extensions shown.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.
- For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

## 5. New Features Summary

This is a minor release where the functionality is migrated as is and adapted to new Microsoft Dynamics 365 Business Central features as needed.

**One new features is worth mentioning here:**

### **Automatically flag the container as “Ship” in a Warehouse Shipment**

On the Location Card a boolean Container Pick and Ship is added, if this setting is No (default value), then the current functionality is valid.

If this setting is set to Yes, then registering the pick lines with that container, will automatically flag the container as "ship" on the Warehouse Shipment Container Assignment page. The customer does not need to take the second step and registering the pick automatically updates the Warehouse Shipment Line field "Quantity to Ship".
