This May release replaces Food for Microsoft Dynamics 365 Business Central 2020 Spring Update and is based on Update 17.3 for Microsoft Dynamics 365 Business Central 2020 Release Wave 2 (Application Build 17.3.202105).

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

- For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.
