This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2020 Release Wave 2.

This March release replaces Food for Microsoft Dynamics 365 Business Central 2020 Spring Update and is based on Update 17.3 for Microsoft Dynamics 365 Business Central 2020 Release Wave 2 (Application Build 17.3.53919).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.
- For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

5. New Features Summary

This is a major release where the functionality is migrated as is and adapted to new Microsoft Dynamics 365 Business Central features as needed.

Two new features were already released in 16.5, but are worth mentioning here:

Insights in Item Cost Bases

To give more insights on Cost Basis a Factbox is added to the Item Card and Item Variants which gives information on the used Cost Basis, Cost Value and Last Cost Value Date.

Cost Basis Adjustments

Our existing Cost Bases functionality is extended with Cost Basis Adjustments.

This functionality allows for additional costs to be added to the previously calculated base costs.

Think of extra charges such as transport, handling, fuel surcharge and many more, which you do not want to specify on a sales invoice, but do want to pass on to the customer and therefore include in the cost price.
