1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2021 Release Wave 1.

This September release replaces Food for Microsoft Dynamics 365 Business Central 2020 Fall Update and is based on Update 18.1 for Microsoft Dynamics 365 Business Central 2021 Release Wave 1 (Application Build 18.1.202109).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.
- For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

Starting the release (BC18.1-September) we deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

5. New Features Summary

This is a major release where the functionality is migrated as is and adapted to new Microsoft Dynamics 365 Business Central features as needed.

To-Increase Food has been modified or integrated with new Microsoft functionality:

1. NAVFood and Scanning -Enhancement functionality.

- To support production picking with containers we allow an entire container to be moved (take and place) even if the container quantity exceeds the pick quantity. The users can then consume from the production container what is needed and then return the unused quantity still on the container to the warehouse. This capability is mentioned in the 2nd bullet point.
- This ability to over pick was never implemented in the Anywhere picking process. In the Anywhere process the system detects the excess quantity and requires that it be removed from the container before the entire container may be picked. This is exactly what you would want when picking for a shipment which is what the Anywhere process was designed to handle. The fact that this does not work for production picking is something that got missed when we implemented production containers.

2. Inventory Document.

- Inventory documents are a new concept in BC introduced by Microsoft in 18.1 version. In essence they provide a wrapper (header and lines) around the item journal for positive and negative adjustments.
- Food related modifications have been done in the inventory document.
 - 1. Alternative Quantity.
 - 2. Easy Lot Tracking.
 - 3. Container.

Microsoft is continuously adding new features in the application directly and via Feature Management. Sometimes these are public preview and will be made generally available in future releases, in other cases, they are already general available, and you have the choice to activate them.

Currently, we are not testing compatibility with all new features or combinations.
