1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2021 Release Wave 1.

This October release replaces Food for Microsoft Dynamics 365 Business Central 2020 Fall Update and is based on Update 18.1 for Microsoft Dynamics 365 Business Central 2021 Release Wave 1 (Application Build 18.1.202110).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

The extensions in the TI- ... folders are mandatory and part of the base installation for To-Increase applications. They are also "Excluded" from the Extension Management page to limit the number of extensions shown.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.
- For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

The granules mentioned above will be installed as extensions. The previous Product Registration page is no longer available.

5. New Features Summary

This is a major release where the functionality is migrated as is and adapted to new Microsoft Dynamics 365 Business Central features as needed.

Two new features are released in 18.1.202110.0:

Quality Control - Create Sub-Lot Wizard

When It is sometimes necessary to reclassify a portion of a lot into a new lot. This is typically done because that portion of a lot (perhaps in a bin or a container) has been subjected to environmental conditions that has given it different characteristics than the rest of the lot. This is referred to as a sub-lot and this wizard assists in that process of creating the sub-lot. The wizard proceeds in 7 steps.

The wizard can be run directly or from the item card or list or the lot information card or list. When run from the lot information pages, then the first step of the wizard is skipped.

Enhanced Lot Tracking – Lot Status Summary

This functionality has been implemented but as an enhancement to the Item Availability by Lot page. This page was introduced in version 18 and has been modified to support FOOD features. One key modification is the support for Lot Status. Since lot status is all about availability of lots it seemed that this would be a natural place to provide a summary by lot status. The page as it was implemented displayed one row per lot with some additional data from the lot information (e.g., lot status and supplier lot number) and several quantities (e.g., on hand, scheduled receipts, and gross requirements). This has now been enhanced to include additional rows for each lot status showing totals of the quantities for each lot with that lot status. The rows are presented in a tree view with the top level being the lot status summary rows and the second level being the rows for each lot.

Microsoft is continuously adding new features in the application directly and via Feature Management. Sometimes these are public preview and will be made generally available in future releases, in other cases, they are already general available, and you have the choice to activate them.

Currently, we are not testing compatibility with all new features or combinations.
