1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2022 Release Wave 2.

This release replaces Food for Microsoft Dynamics 365 Business Central 2022 Wave 1 Spring Update and is based on Update 21.2 for Microsoft Dynamics 365 Business Central 2022 Wave 2 release (Application Build 21.4.202310).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

2.2 OnlineHelp especially for EmbedApp

The EmbedApp may respond differently in some cases than the standard Microsoft Dynamics 365 Business Central SaaS environment.

We see this especially when installing 3rd Party ISV apps and when using so-called Connector Apps.

3. Deliverables

Besides 2 On-Premise packages (W1 & NA) we also deliver a SaaS EmbedApp package.

This SaaS EmbedApp is only available in the USA, localized as NA, in a Microsoft Azure Cloud environment, managed by To-Increase.

The extensions in the TI- ... folders are mandatory and part of the base installation for To-Increase applications.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.

- For Anywhere for Food the out of the box processes are delivered for the Warehouse Scanning Solution Anywhere Mobility Studio.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

As US EmbedApp follows Modern Lifecycle Policy of Microsoft it follows the majors and minors for Microsoft Dynamics 365 Business Central SaaS.

Microsoft is continuously adding new features in the application directly and via Feature Management. Sometimes these are public preview and will be made generally available in future releases, in other cases, they are already general available, and you have the choice to activate them.

Currently, we are not testing compatibility with all new features or combinations.

5.2 Remarks on Microsoft features

Behavior changes due to **Auto-save as you work**.

Microsoft added the new feature “Auto-save with every field save” in the 2022 Wave 2 release, when this is enabled changes (OnModify) made by the user will be saved immediately.

This has resulted in Business Central responding differently to alerts and errors as users are used to.

Also To-Increase is not able to change this behavior by adjusting code.

Therefore we advise not to enable this feature, of course, users may use this feature if they want to, but To-Increase cannot adjust the changed behavior if users complain about it.

In 2020 Wave 2 release Microsoft added the feature **New sales pricing experience**, as To-Increase we do not support this new feature at the moment.

The To-Increase pricing enhancements are built on the old pricing system of Microsoft.

As the new sales pricing experience is still under construction, auto enablement is even postponed several times, and old pricing system is not yet retired we advise not to enable this feature as this will give an error.

Microsoft is busy to make changes to the new sales pricing experience, but not expect them to be ready before Q2-2023, so Microsoft postponed the retirement of the old pricing system.

6. Post Release Defects Resolutions

In case of an Error, To-Increase may provide a Hotfix on a reasonable efforts basis in a way it considers appropriate in its discretion. To-Increase cannot be obliged to provide Hotfixes if Client has not deployed the latest Release or the Release second to the latest Release and/or is not using a supported version of Microsoft Dynamics.

To ensure our customers can fully leverage the latest enhancements, features, and quality improvements, we are committed to providing increased support by keeping them updated with the most recent releases. Our data indicates that customers on the latest version experience fewer issues and requests, demonstrate greater resilience, and effectively enhance their organizational efficiency.
